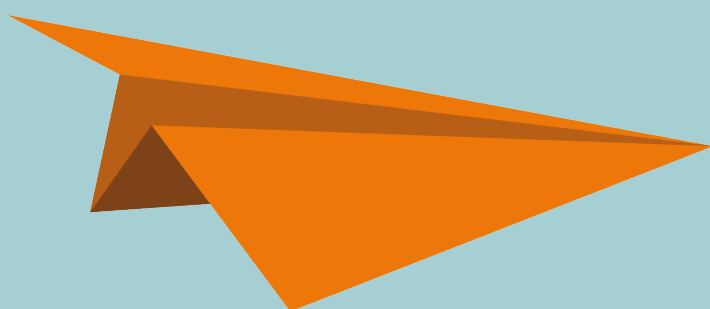

Data Usage and Legal Compliance

When working with data, it's essential to follow all applicable laws and regulations. You are fully responsible for making sure your actions are compliant, but we're here to offer guidance. Depending on how you plan to use the data, there are several important—though not exhaustive—rules to keep in mind:

Non-Mailing Indicator

Some organizations are marked with a Non-Mailing Indicator. These organizations have notified the business registry that they do not wish to receive physical mail or door-to-door visits at their registered address. It's crucial to respect their preferences. By enabling this indicator in your selection, you can exclude these addresses. [Learn more...](#)

Email Marketing

The Telecom Act (Article 11.7) outlines the rules for sending emails. Promotions, newsletters, and electronic messages advertising a product, service, idea, or charity can be considered spam. How can you avoid spamming? Make sure you meet all requirements. [Read more...](#)

Telephone Customer Approach

If you plan to use selected addresses for telephone outreach, keep in mind that contacting potential customers by phone for commercial, charitable, or idealistic purposes requires prior consent under the Telecom Act—unless there's an existing customer relationship or you're contacting a legal entity. This applies to all individuals, including sole proprietors, partnerships, and professional associations. Other business types aren't subject to these rules. You can filter by business type in the selection options for more targeted outreach.

Privacy Legislation

Since May 25, 2018, the General Data Protection Regulation (GDPR) has been in effect. This European law covers the handling of personal data. It's essential to comply with these regulations. [Read more...](#)

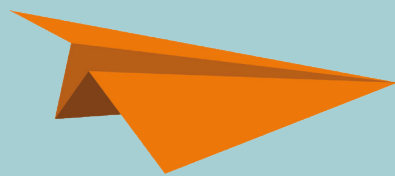
